22/07/01 Chairman's remarks

The Chairman welcomed everyone to the meeting.

22/07/02 To elect a Vice-Chairman

Cllr Hornsey was elected Vice-Chairman.

22/07/03 Apologies

On a proposal from Cllr Lobley, seconded by Cllr Lowen, it was **RESOLVED** by a unanimous vote that apologies were received and accepted from Cllrs Mrs Grimble, Greenway and Fletcher having considered their reasons for absence.

22/07/04 Declarations of Interest

Cllr Lowen declared an interest in agenda item 14 as resident of a property on the boundary of Manor Park.

22/07/05 Minutes

On a proposal from Cllr Lobley, seconded by Cllr Powell, it was unanimously **RESOLVED** following a vote that the notes of the meeting held on 25th April 2022 be approved and signed as the minutes.

22/07/06 Clerk's Report

The Clerk had nothing to report on this occasion.

22/07/07 Finance Matters

Members received a financial report to 30.6.22.

22/07/08 Trees/Planting/Grass cutting

- a. Cllr Powell reported tree works application 145089 to remove a large Willow tree at a property on Sudbeck Lane.
- b. The Tree Survey Report has identified nothing urgent, but maintenance is required to a number of trees and on a proposal from Cllr Lobley, seconded by Cllr Powell, it was unanimously **RESOLVED** following a vote to ask the Clerk to obtain quotes for the next meeting.

22/07/09 Footpaths

- a. Cllr Mrs Watson had nothing to report on this occasion.
- b. Consideration was given to erecting a sign on the footpath from Eagle Drive to Manor Park to prohibit horse riding and cycling and for use by pedestrians only and on a proposal from Cllr Lobley, seconded by Cllr Pikett, it was unanimously **RESOLVED** following a vote for the Clerk to purchase a bespoke sign. On a proposal from Cllr Lowen, seconded by Cllr Lobley, it was unanimously **RESOLVED** following a vote to set a budget of £200.00 to achieve this.

22/07/10 East Midlands in Bloom Competition

Judging day is 13th July and Cllr Lobley went through the route and on a proposal from Cllr Lobley, seconded by Cllr Hornsey, it was unanimously **RESOLVED** following a vote for the Clerk to provide refreshments at a cost of £50.00.

22/07/11 Litter and Dog Bins

Consideration was given to replacing and purchasing new bins as follows:

1no new dog bin and 1no replacement litter bin on Ryland Road by the Village Hall

1no new dog bin – Poachers Rest

2no new double recycling litter bins on Cliff Road

1no replacement bin on the Ryland Road playing field

On a proposal from Cllr Lobley, seconded by Cllr Pikett, it was unanimously **RESOLVED** following a vote to purchase these at a total cost of £2,119.00.

The two double recycling litter bins have advertising panels, and the Clerk has enquired from local businesses if they would be interested in advertising and two have taken up the offer for a charge of £25.00 per quarter.

22/07/12 Lagoon Area

The Clerk reported that she is waiting for a meeting to be arranged with Bishop Burton College.

22/07/13 Highway Matters

- a. **Community Speed Watch Scheme** – still short of volunteers – only 1 session in June
- b. Update - Extending the 30mph speed limit on Cliff Road, extending the 30mph speed limit on Lincoln Road and the traffic regulation order for Beware of Horses on Heath Lane/Cliff Road – nothing to report currently – chased LCC 27.6.22
- c. New development adoption Hawks Road and Hampden Close – request to add to the grass cutting contract. On a proposal from Cllr Lowen, seconded by Cllr Hornsey, it was **RESOLVED** following a unanimous vote to accept the quote from Glendale to add this to the current contract at £34.00 per cut.
- d. The No Ball Games sign on Westhall Road has faded and needs replacing and on a proposal from Cllr Lowen, seconded by Cllr Lobley, it was **RESOLVED** following a unanimous vote to purchase a new sign with a budget of £100.00 set.

22/07/14 Village Maintenance

Three quotes have been received and on a proposal from Cllr Pikett, seconded by Cllr Hornsey, it was **RESOLVED** following a unanimous vote to accept the quote from Glendale Countryside Ltd. Works carried out will be monitored for comparison next year.

22/07/15 Councillors Reports

Cllr Powell reported that there is a large pothole on Prebend Lane near the entrance of Stonecliff Park – report to LCC. The area at the entrance to the Co-op is in a very bad condition – this has been reported to LCC. Two accidents took place in the village recently; a bus collided with a 4x4 and a hit & run severely damaging a vehicle outside the Pet Shop.

Cllr Mrs Watson reported that a car parked constantly on Sudbeck Lane prevents the grass cutters mowing and it is now very long.

Cllr Lowen reported that the dog bin at the end of the footpath on to Field Close has fallen down the pole again.
