24/03/14 <u>Minutes</u>

On a proposal from Cllr Greenway, seconded by Cllr Hornsey and **RESOLVED** following a unanimous vote that the notes of the meeting held on 12th February 2024 were approved and signed as the minutes.

24/03/15 District Councillors Reports

District Cllr Sebastian Hague reported that Flooding Working Group are looking at the issues of flooding and investigating ways they can assist residents. The streetcleaning vehicle can be requested to sweep the village at any time dependent on its availability. The District Council passed its budget and will be concentrating on sports and arts development.

24/03/16 Planning Application 146801

This item was brought forward on the agenda to allow a discussion whilst members of the public were still in attendance and had expressed concerns regarding this application during the public open forum.

Eastfield Lane is a narrow lane and vehicles would not be able to give horses, cyclists and walkers sufficient room to pass safely and in accordance with the widths recommended in the Highway Code. Flooding is an issue particularly outside number 66. It was agreed that the PC would object again on the principals it stated originally with increased concerns regarding the flooding issues and to send a representative to speak within the 5 minute alloted slot at the WLDC Planning meeting on the 29th March. On a proposal from ClIr Briggs, seconded by ClIr Mrs Chapman and **RESOLVED** following a unanimous vote to delegate ClIr Powell, the Clerk and a resident to meet and decide on an appropriate response.

He would be unable to make representation on this application as he is a member of the Planning Committee, but Dist Cllrs Mrs Rodgers and Swift would be able to make representation on the PC's behalf if they are able to do so. *8.05pm* The meeting resumed.

Christ's Hospital Endowment Trust – Cllr Lobley reported that there had not been a meeting of the committee recently.

24/03/21 Village Hall Development

The committee has sent a report to the council giving an update on how funding applications were progressing and the following proposals for the way forward which were circulated with the agenda:

- The feasibility of moving the parish council's administrative base and the library to the village hall site in a new or extended building.
- The support of the council for capital grant funding for phase one of the redevelopment project.
- Formal discussions as to future governance arrangements which would maximise funding opportunities, while providing the necessary safeguards for both council and the trust.
- Consideration of funding a time-limited project manager post to carry the project forward.

Prior to proceeding it was suggested that the council takes legal advice. On a proposal from Cllr Briggs, seconded by Cllr Lobley, it was **RESOLVED** following a unanimous vote for the PC to support the strategy described in this paper as a vehicle between the PC and Village Hall Trust as to how this can be enabled.

24/03/22 Council and Committees:

- **b)** Local Council Award Scheme a copy of the Council's Action Plan had been circulated with the agenda and on a proposal from Cllr Greenway, seconded by Cllr Mrs Chapman and **RESOLVED** following a unanimous vote to agree the plan.
- c) An invitation to the Chairman to attend the monthly engagement meetings with the Home Office/WLDC regarding the future use of RAF Scampton has been received; Cllr Greenway is unable to attend via Zoom and therefore on a proposal from Cllr Greenway, seconded by Cllr Mrs Chapman and **RESOLVED** following a majority vote (9 for, 2 abstentions) that the Clerk will attend on behalf of the PC and report back.

24/03/23 Councillors' Reports

Cllr Lowen reported that he had a meeting with Sheltons and Mr J Hodges (Welton FC) to walk the pitches at Manor Park and Ryland Road with regard to drainage issues. Full drainage to Manor Park has not been redeveloped since the late 1990's. The estimate to rectify the problem at Manor Park would be in the region of £70 - £110,000 for which funding may be available through the FA and the Ryland Road pitch approximately £20,000. The matter will be an agenda item for the next Facilities & Recreation Committee meeting.

Cllr Pikett reported that the condition of the road surface on Mill Lane is dreadful. The matter will be an agenda item for the next Amenities & Services Committee meeting.

8.45pm On a proposal from Cllr Greenway, seconded by Cllr Mrs Chapman, it was **RESOLVED** following a unanimous vote for the meeting to be adjourned to allow for a presentation to the Clerk on her 20th Anniversary of working for the PC. *8.52pm* The meeting resumed.
