# 24/04/20 Planning

a) Cllr Powell read out the Planning Report recording applications for consultation and decisions made by WLDC since the last meeting which had been circulated with the agenda.

**b)** To make comments/observations on the following planning applications:

**147981 – Bluebells, 24 Sudbeck Lane** - Planning application for replacement timber framed double glazed windows with flush uPVC double glazed wood effect windows and doors – No Comments/Observations

**148093 – Woodcot, Market Rasen Road** - Planning application for conversion of garage to annexe – No Comments/Observations

146801 - Land at Eastfield Lane, Welton - Application for 109no dwellings

Cllr Powell reported that he had attended the WLDC Planning Committee meeting on 27<sup>th</sup> March and a site visit has been arranged for the 18<sup>th</sup> April; it will be discussed again at the WLDC Planning Committee meeting to be held on the 24<sup>th</sup> April.

c) Update on the Beal Homes transfer of land off Prebend Lane – an email has been received from WLDC providing an update which the Clerk read out:

"The delay in the transfer of the land, is due to Health and Safety concerns from Beal, specifically managing a large live site alongside a large area of land being available for public access.

As such, based on the information Beal's has submitted in terms of their delivery programme we have agreed to vary the existing s106 agreement to push back the delivery of the Recreational Land. The benefit of formalising this is that all parties are clear when the obligation will be delivered whilst also ensuring the site is safe. I have instructed our legal services to vary the trigger in the obligation so that the land will be prepared and offered for transfer to the Parish Council on occupation of the 210<sup>th</sup> open market dwelling. This will ensure that the majority of houses are completed and make the management of development activities and public access much easier to manage for both Beals and the Parish Council, who I am sure on receipt of the recreational land will be keen to facilitate public access soon after. We have liaised with the other signatories of the s106 agreement and explained the rationale. It is hoped that an amended draft including the updated trigger will be circulated to the signatories within the next week and that the agreement can be signed soon after to allow all parties to proceed on this basis and make the necessary preparations to deliver the obligation when safe to do so."

The Council will need to decide on the use of the land for the future of the village and this will be discussed by the Planning & Development Committee – the Clerk will arrange a meeting in June/July.

On a proposal from Cllr Briggs, seconded by Cllr Bailey, it was **RESOLVED** following a majority vote (9 for, 2 against) that in the event that it became feasible to develop the Village Hall in Phase 1; the Parish Council should consider re-locating the Parish Office for a peppercorn rent.

## 24/04/23 Council and Committees:

- a) Update for Annual Parish Meeting Thursday 23<sup>rd</sup> May NP Working Group will make a presentation of the draft new plan still waiting to hear from LCC and Anglian Water.
- b) Manor Lane a copy of the proposed waiting restrictions has been circulated to all members and to residents/businesses that may be affected. It will inevitably push parking to other areas around the centre of the village. The buses do have difficulty in passing along Manor Lane when vehicles are parked inconsiderately. There is no merit for restrictions on both sides of the lane. 8.00am 6.00pm waiting restriction rather than "at any time". It may be an opportunity to change the bus route.
