24/01/14 Minutes

On a proposal from Cllr Greenway, seconded by Cllr Lobley it was unanimously **RESOLVED** following a vote that the notes from the meeting held on 23rd October 2023 were approved and signed as the minutes.

24/01/16 Welton Music & Arts Festival 2024

A discussion took place on the branding ideas that had been presented and the naming of the event. On a proposal from Cllr Mrs Watson, seconded by Cllr Greenway, it was unanimously **RESOLVED** following a vote to call the event Welton Music & Arts Festival and agreed the "Splash of Paint" as the branding for the leaflets and posters.

The Sunday street food event was discussed and on a proposal from Cllr Lobley, seconded by Cllr Greenway, it was **RESOLVED** following a unanimous vote to agree a budget of £3,000 for the Sunday event. £2,000 for entertainment and £1,000 for the hire of tables and chairs.

24/01/17 Financial

- b. On a proposal from Cllr Mrs Grimble, seconded by Cllr Mrs Watson, it was unanimously **RESOLVED** following a vote to use the shorter version of the advertisement for the 2024 awards.

24/01/19 Christmas Event

Debrief – everyone felt the event had gone well and another success.

Health & Safety – The Clerk reported that an accident involving a child and spilt hot mulled wine had occurred at another event in the County and in future it would be sensible to have cups with lids – 200 have been donated by Stokes.

Black Bull – they had hired a food outlet at their own expense which encroached onto the footway from the pub car park, with no contribution given to the PC charities and will be told they cannot have a food van at PC events, without consultation with the PC.

Music – stop playing while band playing, and the choir should be on the green.

On a proposal from Cllr Mrs Watson, seconded by Cllr Mrs Grimble, it was unanimously **RESOLVED** following a vote to hold the Christmas event on Sunday 1st December 2024.
