Are there any benches, fences, or railings that could use a fresh coat of paint? Maybe the well on Sudbeck Lane?


Happy to hear any suggestions that you may have, and whether it's something that will be allowed?

RE: WELTON, CLIFF ROAD-PROPOSED 30MPH SPEED LIMIT EXTENSION

Lincolnshire County Council recently received a request to review the speed limits at the above location.

The proposed reduction in speed limit, to 30mph as shown on the attached plan has been justified against the criteria set out in the council's speed limit policy.

I look forward to receiving any comments you may wish to make. If I do not receive a response by **2nd October 2025**, I will assume that you have no objections to the proposal.

- c. School streets involve creating a campaign involving 'cohorts of well-informed parents and residents and working in co-operation with the local school', Modeshift STARS involves the school creating a travel plan and a conversation with LCC stated that due to the location of the school at the end of a cul-de-sac and not a through road the current measures in place are the ones they would recommend.
- d. Copy of email from residents below.

Email 1 (Speeding around the village):

I've undertaken speed readings for many years and even to my ageing ear, speed bands are clearly noticeable. Walking around the village I've noticed that speeds are increasing and perhaps one factor is the acceleration provided by hybrid and electric vehicles (as well as the boy/girl racers) – an issue that will not go away.

Support for a 20mph limit should not be limited by the ability of the Police to monitor and manage it – rather a gradual behaviour change to generally slow traffic and enable pedestrians to cross roads safely, particularly around sensitive areas.

The village entrance gates similarly to be aimed at changing perceptions of the urban areas back to the rural, and not constrained by the requirement to maintain them – to support rather than detract from the need for a static speed sign.

Looks like you have already highlighted the benefits and started the process of engagement with the Authorities – knocked back at the first hurdle.

My point is that if these are good ideas for the village and if the PC has a formal motion of support them, then there are more direct and elevated approaches that can be made within Lincolnshire CC etc.

Getting the villagers onboard would be key and if required I'd be happy to seed the idea with TRO and Transport officers when I am in their offices (usually weekly).

The pressure groups 'Brake' and '20splenty' have background details and offer assistance, but are unlikely to be able to force the issue – that has to come from a PC speaking on behalf of the residents - and needs to be both a forceful and prolonged approach.

The NP could help there as could support letters from businesses, schools, health centre etc – perhaps Roy could adopt the mission, take the case for change paper and push for LCC action as the evidence from Cambridgeshire is positive and being investigated by the Highway Authority.

Subject: RE: Speed control

In answer to your question, yes, the PC has considered both of these traffic calming measures and I attach copies of email exchanges relating to the 20mph request which County Cllr Sue Rawlins was pursuing with LCC, as you know the PC cannot act on this alone, but nothing ever came of it. Amenities & Services Committee minutes 24/01/44 and 24/03/36 refer to this and are available on our website.

The gateways have also been considered by the PC on numerous occasions and the outcome was that there is only one suitable entrance to install these, which is Cliff Road and as we have a static speed sign located there it was decided not to add to the street furniture in that area.

The PC has taken action in other ways and is a member of the Community Speedwatch Scheme with regular sessions carried out every month; PC Toyn joins them and issue tickets on the spot when his timetable allows.

The PC has paid to install static speed signs on Cliff Road, Hackthorn Road and Eastfield Lane and purchased 30mph wheelie bin stickers which were delivered to every household in the village.

We have currently an ongoing request with LCC to extend the 30mph speed limit on Cliff Road to beyond the new development, on Hackthorn Road to extend the 30mph speed limit to the junction with Mill Lane and on Lincoln Road to just before the entrance of Dunholme Lodge (which is progressing).

Hope this brings you up to date with the measures that the PC has taken regarding these matters.

Email 2 (Speeding at the top of Poacher's Rest):

I wonder if you can be of any help to us, we live at the top end of poachers rest and every day cars come speeding down the road, far quicker than what is safe, we have had a few near misses pulling out of our driveway, it's clear when we look then they just come speeding out of nowhere. Last time was Saturday afternoon. Wonder if there could be speed checks done with looking in to perhaps speed bumps? Appears to be ever since the new houses were built and the bottom of poachers rest was opened up. We also have an elderly cat that likes to wonder out, we can't keep her in as she won't use a litter tray. Feel it's not safe and I'm sure we are not the only residents that it's happening to.

Subject: Footpath into Welton

Good morning,

I wanted to get in touch regarding the footpath which runs from the A46 roundabout part way down Lincoln Road towards Welton.

I know this has been a subject of many a debate and conversation, but today I experienced it first hand and felt I needed to get in touch.

This morning I took my wife's car to Centurian garage and decided to run back - practically, my wife couldn't come along to give me a lift back so my only option was to walk (or run) back into the village. Until I actually used it, I didn't appreciate how pointless the path is.

Whilst I've driven past it hundreds of times, I never fully recognised how short it is. The path runs part way down then, at its end, there is a completely pointless m2 or so 'path' on the opposite side of the road. To get into Welton you have no option but to walk on the road - the verge is naturally uneven and so isn't necessarily safe to walk on. In wet weather this would be even more unusable. Fortunately I was safe this morning as cars swerved round me, but I felt very unsafe on that road - one car coming a bit too fast, or 2 busses passing on either side and it would be so easy for someone to get hit by a vehicle.

Expanding the path to Honeyholes Lane would be a start, although the first part of Honeyholes Lane doesn't include pavement so, again, one is forced to walk on the road.

I realise that when the roundabout was built that the contractor would have included the footpath as a gesture towards the community but it really is pretty pointless. Coming from the A46 or going that way from Welton, you aren't greeted with a safe way to walk, run or cycle. Rather you are teased into it with the realisation that you then have to put your life at risk by venturing onto a busy road.

My point of writing is to ask what can be done to have this path extended into Welton? I realise that land ownership would obviously play a part, as does cost, but is there no way this can be re-looked at? What could be a wonderful addition to help and encourage people to exercise is quite the opposite. I do not look forward to having to retrieve my car this evening!

I would really appreciate your thoughts and am open to a conversation about how this footpath can be fully extended into Welton.
